2008 REUNION AND ANNUAL MEETING PORTLAND MAINE

Our 2008 Annual Meeting and Reunion will be held in Portland, Maine, on Friday 20 June and Saturday 21 June 2008 at the Holiday Inn Hotel and Convention Center By The Bay located near the harbor and the older historic port district (called "Old Port"); a district known for its cobblestone streets, 19th century

brick buildings and fishing piers. The district is filled with boutiques, restaurants and bars.

Portland was originally called "Machigonne" by the Indians who first lived there. It was settled by the English in 1632 as a fishing and trading settlement and renamed Casco. In 1658 its name was changed again, this time to "Falmouth." A monument at the end of Congress Street where it meets the Eastern Promenade is a tribute to the four historical names for Portland.

Portland has been destroyed many times. In 1675, the village was completely destroyed by the Wampanoag Indians during King Philip's War. It was rebuilt, only to be destroyed by the same tribe again several years later. On October 18, 1775, the o



again several years later. On October 18, 1775, the community was destroyed yet again, bombarded by the Royal Navy during the American Revolutionary War.

Following the war, a section of Falmouth called "The Neck" developed as a commercial port and began to grow rapidly as a shipping center. In 1786, the citizens of Falmouth formed a separate town in Falmouth Neck and named it "Portland." Portland's economy was greatly stressed by the Embargo Act of 1807 (prohibition of trade with the British) and the War of 1812. In 1820 Maine became a state and Portland was selected as its capital. By this time both the Embargo Act and the war had ended and Portland's economy began to recover. In 1832 the capital was moved to Augusta.

Today Portland is Maine's largest city and has won many accolades. It has been rated as the number one city for small business vitality, sixth as the best town in which to relocate, and twelfth in Fromer's list of "top travel locations." It has one of the northeast's finest Art Museums and has been rated as the 7th best "Art Town" in the United States.

The Museum's collection contains more than 18,000 fine and decorative works of art dating from the 18th century to the present. The collection includes paintings, sculpture, prints, photography, glass and ceramics, artists' books, furniture, and much more. Works by artists such as Frederic Edwin Church, Winslow Homer, Rockwell Kent, John Singer Sargent, Andrew Wyeth, are among the works of the artistic heritage of the United States. An excellent collection of Maine artists are also included as well as paintings of the major European impressionists and

surrealists including Mary Cassatt, Edgar Degas, René Magritte, Claude Monet, Edvard Munch, Pablo Picasso, and Pierre-Auguste Renoir.

Before statehood Maine was the "Northern District" of Massachusetts and later the "District of Maine". Many DELANOs moved to Maine and settled there in the 1700's. DELANOs of note in the Portland area include two Keepers of the Portland Head Light completed in 1791. The third Keeper of the Light, from 1796 to 1820, was Barzillai Delano (GHAAHD p. 182) and the ninth Keeper from 1854 to 1861, was James Delano (GHAAHD p. 186), a grandson of Barzillai. Portland Head Light is mentioned in two *Bonnes Nouvelles* articles—one in NL# 28 (Sep. 1998) and one in NL # 43 (June 2003).



Getting There:

By car:

Portland is located on I-95 so those traveling either from the north or south can easily find their way to this city.

From the north take I-95 to I-295 to Exit 7 (Franklin St.). Stay on Franklin Street for five lights. Take a right onto Middle Street (which changes into Spring Street), travel about 1 mile and you will find the Holiday Inn by the Bay on the left. From the south: Take I-95 Exit 44 to I-195, to Exit 7 (Franklin Street) and follow the route above.

By air: Seven Airlines serve Portland. Non-stop service is available from Chicago, Detroit, Cinncinati and the major East coast airports from Washington D.C. to Boston. The Portland Jetport is located south of the city and is also about 10 minutes from the Holiday Inn. Courtesy vans to the hotel are available.

By Rail: Portland has daily Amtrak Service from Boston's North Station with five trains called the *Downeaster*. The trip takes about 2 hours and 25 minutes



and the Portland Amtrak station is about 10 minutes from the Holiday Inn. Courtesy vans to the hotel are available.

Reunion Advance Registration and Reservations:

To adequately plan and support the meals and other reunion events, we must have advance notice of those who plan to participate in each event. Registration and Reservations should be made by 12 June 2008.

Accommodations:

We have blocked 25 guestrooms for Friday night 20 June, and Saturday night 21 June, at a rate of \$149.00 plus 7% tax or about \$159.43 per night. We have also blocked five guestrooms for early arrivals on Thursday 19 June at the same rate. There will be an extra charge for additional adults in these rooms. Individual guestroom reservations must be made **prior to Monday 19 May, 2008** to secure these rates. We strongly suggest you call at your earliest convenience to assure obtaining a room at the blocked rate. Please call the Holiday Inn By the Bay at (800) 345-5050 or (207) 775-2311. All guests should identify themselves as members of the **DELANO KINDRED Reunion** Group. You will receive a confirmation number for your room reservation. Room reservations can be cancelled up to 6:00 PM on the date of arrival without penalty.

Reunion Registration:

Registration will be held near the Connecticut / Rhode Island Room from 4:00 PM to 6:00 PM. Registrants will receive a "Welcome Envelope" containing Reunion information and nametags. Late registration will be held from 8:30 AM to 9:00 AM Saturday in the Connecticut / Rhode Island Room prior to the Annual Meeting.

Events:

The Friday night **Welcome Light Buffet Dinner**, will be held in the Connecticut / Rhode Island Room at 6:00 PM.

The Buffet will be served at 7:00 PM with a cash bar available starting at 6:00 PM. It will be a night of fellowship and pleasantries where one can meet and greet new members as well as visit with old acquaintances. Genealogical consultations will also be available. Other events may also be scheduled that evening. The buffet menu will include: Soup Du Jour, Assorted Sliced Deli Meats, Assorted Sliced Cheeses, Salads, Stir-Fry Maine Shrimp and Marinated London Broil, Assorted Vegetables, Breads and Rolls, Desert and Beverage.



On Saturday at 9:00 AM, the 2008 Annual Membership Meeting will be held in

the Vermont Room. We plan to have the minutes and the committee reports available in advance at registration to reduce the overall time of the Annual Meeting as we did last year. We plan to have the group photograph after this meeting.

Lunch and Tour will be at each individual's option to increase everyone's flexibility. A choice of either a narrated trolley tour of historic Portland (with a stop at Portland Head Light) or a narrated boat tour of the Portland Harbor, passing nearby islands and lighthouses in Casco Bay is planned. Each tour is expected to cost \$15.00 per person. If you wish to take one of these tours please so indicate on the Reunion Reservation form enclosed with this newsletter. Those wishing to take these tours may pay when they register at the Reunion. It is planned that the trolley tour will stop at Wadsworth Longfellow house (Henry Wadsworth Longfellow's home) in time for the last docent



escorted tour of his home for the convenience of members who may care to take that tour as well.

The **2008 Banquet Dinner, Saturday,** will be served at 7:00 PM in order to give those on tour time to freshen up after returning to their guestroom. A cash bar will again be available starting at 6:00 PM. We are very fortunate to have Earle G. Shettleworth, Jr. as our **2008 Banquet Speaker.** He will tell us about Portland two centuries ago. He is a native of Portland and attended Colby College, and Boston University. At the age of thirteen, Shettleworth became interested in historic preservation through the destruction of Portland's Union Station in 1961. A year later he joined the Sills Committee which founded Greater Portland Landmarks in 1964. In 1971 he was appointed by Governor Curtis to serve on the first board of the Maine Historic Preservation Commission, for which he became architectural historian in 1973 and director in 1976. Shettleworth has lectured and written extensively on Maine history and architecture, his most recent publication being *Portland* in the Arcadia post card series. He currently serves as chair of the Capitol Planning Commission, the Blaine House Commission, and the State House and Capitol Park Commission. In March, 2004, Governor Baldacci appointed Mr. Shettleworth as State Historian.

Vivian Baughcom

We received belated word that Cousin **Vivian Darnell Baughcom** of Brenham, Texas passed away on 16 September 2006. Born on 13 September 1912, she had just celebrated her 94th birthday. Cousin Vivian had been a loyal member of the DELANO KINDRED since 2003.

She was the general office manager for the Amicable Life Insurance Company in Corpus Christi, TX, for 35 years and an accomplished artist and writer. She was an active member and a leader in several art organizations including the Corpus Christi Fine Art Association, the South Texas Art Association, the Watercolor Society of South Texas and the Western Federation of Watercolor Societies. She was a Mayflower Descendant and a life member of the Cromwell Association of England. She received a Citation of Award for Distinguished Service from the Texas Historical Commission. She was listed in Personalities of the South, the World Who's Who of Women, the Dictionary of International Biography, and the Hereditary Register of the United State of America.

She was preceded in death by her husband, Murray Baughcom, and her brother, Alvin Darnell. She is survived by her daughter, Nancy Boecker and husband Don, four grandchildren and five great-grandchildren, and her sister-in-law Mary Darnell.

Philip C. Davis

Philip C. Davis died at his home in Webster Township, Michigan, on July 2, 2007. He was the husband of Cousin Martha D. Davis. He was born in Spokane, Wash., on Oct. 15, 1921, the son of William B. and Mary Augusta (Maples) Davis. His family moved to upstate New York when he was 12 and after his graduation from high school, he enlisted in the Army Air Force. He was commissioned in 1943 and served as a flight instructor until his discharge as a First Lieutenant in 1945.

He was graduated from Albright Art School in Buffalo, N.Y. in 1948 and joined the staff of the University of Michigan's College of Architecture and Design as an instructor in design and drawing. From 1964 until his retirement, he served as a Professor of Art in the University's School of Art, teaching photography and drawing. He received two Horace H. Rackham Foundation Grants; in 1967 for investigation of historic photographic processes and in 1974 for further investigation of non-silver processes.

As part of the University's Sesquicentennial celebration in 1967, Philip conceived, produced and supervised installation of an exhibition of 264 photographs mounted on steel structures on the Rackham Mall between Hill Auditorium and the Michigan League. A book of these photographs titled "The University" was published by the University of Michigan Press. His other publications included three textbooks, many magazine articles, a limited edition of platinum prints made from noted cinematographer Karl Struss's original glass negatives, and "The Dexter Portfolio," a limited edition of mounted black and white prints. His work is represented in numerous public and private collections, including those of the Detroit Art Institute, the Chicago Art Institute, the International Museum of Photography in Rochester, N.Y. and the Museum of Modern Art in New York City.

In addition to appearances as guest artist, juror and speaker at various events, Phil conducted a series of workshops throughout the country in his "Beyond the Zone System" method of producing photographs using proven scientific testing methods which allow photographers to produce superior photographs through a precise, working knowledge of their chosen materials. He retired as Professor Emeritus of Art in 1985.

Mary Josephine (Drury) Delano

We sadly report the death of **Mary Josephine Delano**, wife of the late Charles Henry Delano, who passed away on 21 September 2007 in the nursing home where she resided on Cape Cod. Born on 2 November 1906, her centenarian lifetime spanned almost the entire 20th Century. She was just one month and a few days shy of her 101st birthday.

A naturalized citizen, she was a native of County Roscommon, Ireland and immigrated to the United Sates through Ellis Island in 1924. She resided in New York City and Taunton, Massachusetts.

We received word from Cousin Martha Davis that her sister **Florence Louise DeLano Gray** passed away at her home near Miami, Florida on August 26, 2007. Florence was born in Kalamazoo, Michigan on February 27, 1926, the daughter of Carl F. and Elizabeth Irene (Lane) DeLano. She was 81 years old and a descendant of Philippe de Lanoy through the Lt. Jonathan branch and the line of William Smith DeLano.

She leaves five children, Michael Gray, Marjorie Gray Dodd, Joanne Gray Korvick, George Gray, Mary Gray Reeves and their families, including 14 grandchildren and four great-grandchildren; two sisters, Cousin Martha D. Davis and Cousin Mary D. Rizzardi, a large extended family, and many friends. She was predeceased by her husband James.

Florence was a long- time, active member of St. Stephen's Episcopal Church in Coconut Grove, as well as the Coconut Grove Women's Club, the Equal Rights Movement, The Nature Conservancy, and The Audubon Society. She was active in various community and religious organizations such as Coconut Grove Cares, El Hogar Home for Boys in Honduras, The Cursillo Community as well as numerous outreach ministries through St. Stephen's. Florence participated in historic events such as the Pedro Pan flights and the Civil Rights movement, and in 2006 received a commendation from the Miami Dade County Commissioners for her community involvement. Throughout her life she was a strong advocate for those in need of justice, peace, respect and dignity.

Russel Walter Patrick

We were deeply saddened to learn of the death of Cousin **Russel W. Patrick** who died at home in Sandusky, OH, on 20 June, 2007 after a brief illness. He was a steadfast and loyal member of the DELANO KINDRED since 1993 and had attended several of our Reunions. He was born in Bellevue, Ohio on 28 May, 1913, son of Walter L. Patrick and his wife Edna V. Humphrey.

Around age two, Russ began visiting the summer cottage of his grandparents, Charles Vernon Humphrey (GHAAHD p.400) and Cora A. Reahm of Bellevue,

Ohio. Located in the upper peninsula of Michigan, Russ spent many summers at the "Celdom Inn," helping build additions to the cottage, docks, boathouses and outbuildings.

Shortly after the attack on Pearl Harbor, Russel married Virginia Gosser of Sandusky, Ohio. They were married on New Year's Eve 1941, just a few weeks before he enlisted in the Army Air Corps at Wright Patterson Field in Dayton. Russ served first as a Sergeant in the 21st Air Depot Group, refurbishing Liberator Bombers at Burtonwood Air Base near Warrington, England. He returned to attend Officer's Candidate School at Fort Monmouth, New Jersey, and was commissioned a Second Lieutenant in the Army Signal Corps in 1943. Lt. Patrick was stationed as a Radio Carrier Officer at Finschhafen, New Guinea, a key base in the battle for northern New Guinea during World War II (1943-1944), and later in northern Luzon, Philippines in 1945.

A descendant of the Lt. Jonathan Delano branch of the family, Russ is the great-grandson of Evaline Amelia DeLano of Adrian, Michigan and her husband Oliver Edwards Humphrey of Victor, New York. Evaline's father, Thomas Nelson Delano had come west to Fairfield County, Michigan in 1843 where he ultimately settled at 15 Butler Street in Adrian. He was engaged in mercantile trade and operated the Addison, Rome and Hillsdale stage line. At age 19, Evaline wrote a journal of her 6-month journey with her father to Clear Creek County, Colorado. She and her father crossed the Overland Trail to take wagonloads of tools and other goods to sell to miners in the Colorado Gold Rush, returning to Adrian just before Christmas, 1861.

Russ was a member of Ohio Chapter of the Society of Mayflower Descendants, serving for many years as its Compact Chairman, and was a lifetime member of the Veterans of Foreign Wars. He often proudly exhibited his restored 13-foot Lyman in the annual Antique Wooden Boat Show, sponsored by the Les Cheneaux Historical Museum, in Hessel, Michigan. He is survived by his wife Virginia and their four children: Kathleen Moore of Marietta, Georgia; Thomas Patrick of Hastings-on-Hudson, New York; Nancy Carney of Minneapolis, Minnesota; and John Patrick of Sandusky; as well as eight grandchildren and two greatgrandchildren.

Charlotte Alice Springer

We were deeply saddened to learn of the death of Cousin Charlotte Alice (Snow) Springer, aged 79 years, of Acushnet, Massachusetts. She passed away on

8 May 2007, at her home, surrounded by her family, after a lengthy illness. She was the wife of Edwin A. Springer; they had been married 57 years.

Charlotte was born on 4 November 1927 in Middleboro Massachusetts, the daughter of the late Marshall A. and Gladys (Keen) Snow. She was graduated from Middleboro Memorial High School, class of 1945. She earned her Bachelor's Degree at UMASS Amherst, in 1949, and went on to obtain a Master's Degree in Education from Bridgewater State College, in 1967.

She married Edwin A. Springer, of East Walpole, MA on 27 August 1949 and started their married life together in Norfolk, Connecticut. In Connecticut for a brief time, she was a state social worker before moving to Acushnet. There she was a school teacher at the Freetown Elementary School for 26 years. She was a lifelong member of the National Education Association and a strong supporter for human rights issues and efforts to increase literacy.

In 1989, Charlotte and Edwin retired to their vacation home in Brunswick, Maine. There she was a member of the Brunswick Welfare Appeals Board, and a Literacy volunteer. She was a member of the Maine Mayflower Society, and also a member and the former secretary of the Penobscot Genealogy Chapter of the Maine Genealogy Association. She and Edwin moved back to Acushnet in 2002 where she became a member of the First Congregational Church of Rochester MA.

She had a great love of line dancing, reading, computer projects, quilting and participating in activities with her friends, and most of all, being with her family. She will be fondly remembered as a devoted wife, mother, sister, grandmother, great-grandmother, and aunt.

We remember Cousin Charlotte as a faithful and steadfast member of the DELANO KINDRED since 1992. She contributed much of her time and effort to the Society as a Director and then as Secretary from 2001 through 2004. She acted as our "on-the-scenes" coordinator for the memorable 2001 Reunion near Bath, Maine.

Captain Samuel Delano's Papers Donated to the Duxbury Rural and Historical Society

The Duxbury Rural and Historical Society (DR&HS) opened its new Drew Archival Library on 23 September 2007. The library is housed in the newly renovated Wright Building situated diagonally across the street from the Ellison High School grounds where the Philip Delano Historic Marker is located. Years ago the Wright Building housed the Duxbury Library, which was moved to a new location. Now the Archival Library shares the Wright Building with the Duxbury Student Union.



The student union half of the Wright Building opened this summer and is designed for the use of Duxbury's middle and high school students. Housing a computer lab, a large screen television, a game room and a lounge area that features a coffee and snack bar as well as a stage for music performances, it became a reality through the helpful partnership of the Duxbury Student Union Association and the Crossroads for Kids Organization—a philanthropic

organization that created several over-night summer camps for inner city children in the Duxbury area.

The reading room of the Drew Archival Library was architecturally designed and decorated to look much like the library's reading room did in 1907 when it opened as the Duxbury Free Library. The archives are home to a number of collections from noted Duxbury families as well as thousands of turnphotographs. of-the-century It's best known collection is the Bradford Collection; multigenerational collection of papers covering many



members of the Bradford family from the late 18th to the mid 20th century. It was on the occasion of the opening day ceremony that the papers of Capt. Samuel Delano Jr. (GHAAHD p 223), donated by the Hoyt Family, were displayed.

Capt. Samuel Delano Jr.'s father, Samuel Delano Sr. (GHAAHD p 210), also a sea captain was owner of a shipyard which lay below the Bluefish River in Duxbury.¹ Besides being known for his

efforts to save the crew of the British ship the RODNEY (GHAAHD p 224 &225), Samuel Jr. in his ship, the PILGRIM,



accompanied his

brothers, Captains Amasa and William Delano, who sailed in the PERSERVERANCE on Amasa's 1803-1807 voyage.²

It was Mr. Franklin Hoyt who discovered these documents and used the most interesting of these

documents, one of Capt. Samuel Delano's logs, to write a fascinating paper which he has read for many organizations. The historical significance of the log is best summarized in Mr. Hoyt's words, as quoted from his paper, "The Delano Sealing Expedition to the South Seas, 1803-1808:"


"I have here beside me an old, dilapidated trunk covered with motheaten sealskin. It came into the hands of my father-in-law,



Clifford Potter, when he found it in the attic of an old house in Duxbury that he purchased in 1910. It looked out onto Duxbury Bay and was at the end of a lane, which they named Plumfield Lane because of a field of beach plums around the house. Mr. Potter found that the trunk was filled with old faded letters, tattered account books, and several ship-captain's logs, belonging to Samuel Delano. I asked Gershom Bradford to look over the contents of the trunk to see if he thought there was anything in it that I might use in preparing an interesting paper. So one evening when he came to my house, I spread out the entire contents of the trunk on our dining room table for him to look over. It didn't take him long to spot this old ship's log. After examining it for a few minutes, he exclaimed, "Here is a wonderful source for your paper." It was a log, written in Capt. Samuel Delano's own handwriting."

Hoyt went on to say "As I learned to read Samuel Delano's old script, I pieced together a most amazing voyage that the Delanos took to the South Seas; in vessels they built in their own shipyard in Duxbury. It was a sealing expedition that was filled with almost daily exciting adventures. This was one of the most

DELANO SILVERSMITHS

Many of us have heard of **Jabez Delano**, the silversmith, but did you know that there were four other Delano silversmiths besides Jabez? An alert reader informed us that if you searched the Internet ("Googled") for "American Silversmiths" you would find Jabez and the others as well. We took our alert reader's advice and this is what we found.

First, let us start with the most well-known DELANO silversmith, **Jabez Delano** (1763-1848). We knew he was in the Lt. Jonathan Branch, but there are many Jabezes in that branch. As it turns out he is not in the line that runs through Lt. Jonathan's second son Jabez (DFIP # 29), but his line runs through Lt. Jonathan's sixth son Thomas (DIFP # 35), through Capt Ephraim Delano (DFIP # 161) to Ephraim's second son Jabez Delano (DIFP # 645). Jabez was born in Fairhaven, MA on 27 April 1763. He married two Delano girls. First he married Debora Delano the daughter of Capt. Calvin Delano (DFIP #155). When Debora died he married Mary Delano daughter of Jethro Delano (DFIP #158). From Jabez's tombstone we learn that he operated his small silver and jewelry shop for 69 years "Sixty nine years thou hast been the occupant of that little shop..." (GHAAHD p 500).

Jabez Delano was one of only two DELANO silversmiths that had a known maker's mark. Note that the initials, possibly a "J" but definitely a "D", placed with a "pellet" on either side were his mark. As usual, the mark is

Delano silversmiths plied their trade in the northeastern United States. **George Washington Delano** (1818-1892) was the son of Thomas Delano (DFIP 404) and Abigail Larry Robbins. Thomas married the widow Abigail L. Robbins on Seguin Island near Georgetown, ME (GHAAHD p 268). George W. Delano married Abigail Bassett Smart in 1835 in Portland, ME (the GHAAHD says Vassalboro, ME). It is believed that Portland, ME was the

location of his business. His maker's mark "G.W.DELANO" is shown here.



Two sons of Capt. Ezekiel Delano and Elizabeth Hutchinson Ingalls were silversmiths. Capt. Ezekiel Delano was master of the *North Sea* when it was lost at sea underway to New Orleans (GHAAHD p 182). Son **Thomas Ingalls Delano** (1818-1892), resided in Somerville, MA (now in greater Boston) and married Maria Louisa Gregg. He worked from 1845 to 1880 as a jeweler in Boston MA and is listed in the city directories at various locations on Washington Street. His younger brother, **Charles True Delano**, (1821-??), also a silversmith, married Elizabeth Ann French. Charles and

Elizabeth resided on Washington Street (GHAAHD p 183). Charles worked from 1855 to 1880 as a jeweler in Boston, MA, and is listed in the city directory at 52 Washington St. According to the city directories he and his older brother worked at 52 Washington Street from 1855 to 1865.

The fifth silversmith listed is **Charles Henry Delano**, (1836-??). He was the son of Jephtha Delano Jr. and Sarah Pitcher (GHAAHD p 147). He was a partner from circa 1865 to 1880 with Henry Guild in Boston, MA. The partnership was known as GUILD & DELANO, manufacturing jewelers. The company was listed in city directories at 2 Winter Street. He appeared on the 1880 census taken at Somerville, MA, listed as a manufacturing jeweler.

While we see that Thomas Ingalls Delano and his brother Charles True Delano worked together at the same location for some time, we do not know if they personally knew or met Charles Henry Delano whose place of business was at least 3 miles east of the brothers' establishment. It is likely they were aware of each other through their professional connections.³

Fairhaven Historical Society Hosts an Exhibition of the Works of Milton K. Delano

On Friday, 12 October 2007 the Fairhaven Historical Society exhibited a collection of 10 pencil and pen sketches plus 2 watercolor paintings by Fairhaven artist **Milton K.**

Delano. The collection is a permanent gift to the Society given by Virginia Delano in memory of her husband. Other paintings and



sketches of Mr. Delano's were loaned to this special exhibit by local collectors. The Historical Society is located in the Old Academy Building, located on the

west lawn of Fairhaven High School. A copy of one of his pictures is shown here through the courtesy of the Fairhaven Historical Society.

Although Milton Delano is known locally as an artist he received national attention for his expertise in scrimshaw, the painstaking etching on ivory or bone. One of only a few indigenous American crafts, it has been practiced for centuries by the Inuit and other native groups along the Northwest Coast. It was adopted by the Yankee whalemen of the early 1800's. President John F. Kennedy was an avid collector of scrimshaw and his wife Jacquelyn obtained a whale tooth and commissioned Milton Delano to create scrimshaw of the Presidential Seal on it as a Christmas present in 1962. We understand that that particular scrimshaw article is buried with the President.

Milton Delano was born in New Bedford, MA on 2 December 1919 and died in Fairhaven on 8 May 1989. His line of descent is Milton¹⁰, Harold⁹, Jethro Coffin⁸, Samuel⁷, Richard⁶, Richard⁵, Richard⁴, Nathaniel³, Lt Jonathan², Philip Delano (de Lanoy)¹.

Cousins Mary Delano and Catherine Delano – Calamari of Buzzards Bay, MA, informed us about the exhibition and traveled to see it. We thank them for telling us about it.

Hudson Corners Cemetery Allegan County, Michigan

Over the years we have had numerous inquiries about the burial location of the children of George Washington Delano (GHAAHD p 356). **George Washington Delano** was the brother of Major **Joel Andrew Delano** (GHAAHD p 357), the author of the second book of the GHAAHD. George's children, grandchildren and perhaps a great grandchild are



buried there. The location of the cemetery is easily found in a Map of Allegan County, but the fact that there were DELANOs buried there was brought to the attention of your editor by **Evelyn Keck** of

Allegan many years ago. She kindly provided a copy of the inscriptions on the gravestones. Still there was no known picture of the cemetery available. In September 2007 Cousin **Herman DeLano** visited the cemetery and took some photographs of a few of the DELANO gravestones.

George W. Delano and Joel A. Delano were brothers whose parents were Sylvester and Parthena Blaisdell Delano (GHAAHD p 355). Both George and Joel served in the Union forces during the Civil War. George, a paroled prisoner of war, lost his life on his way home aboard the steamer SULTANA that blew up in the Mississippi River north of Memphis in 1865. After the war, Joel returned to Indiana before moving north to settle near his brother, Dennis, in Newaygo County, Michigan.

George Washington and Sarah Ann (Cummings) Delano had eight children. Two died young. Of the five remainding two sons, Steven Delano (1863-1909) and George Washington Jr. (1858-1936) as well as his daughter-in-law Mary E. (Garton) Delano (1855-1937) are buried there (GHAAHD p 357). One granddaughter, Hannah B. (Delano) Cooley and, perhaps, one great grandson Delbert Cooley (1909-1970), are also buried there.



We investigated the cemetery listings for Hudson Corners Cemetery on the Michigan "genweb" (the Michigan Genealogy Website) and found only Steven Delano listed as being buried there. Evelyn Keck's information and Herman DeLano's photograph have added additional information about the DELANOs and the Cooley relatives buried there. We thank them for providing this information.
